The Account owner who fulfills the conditions specified in the previous sentence will be entitled to interest on the deposit in the Account at the interest rate valid for the Kombi offer for the first deposit commitment period, as of the date of deposit creation. The above applies provided that the Account owner does not cancel Fund purchase order or purchase order on Investment Certificate before its settlement. In case of failure to comply with the above conditions, the interest rate on the deposit in the Account is 0.01% p.a. from the date the Bank discovers the violation of the above conditions by the Account owner. A 9-month term deposit can also be closed separately with the interest rate valid for ČSOB Term Deposits for the respective term of the deposit.
