Common provisions for Public and Private Placements:

The entry fee is determined based on the amount of the investment and the size of the Private Banking Client's total portfolio in the Funds.

The entry fee may be reduced with regard to the total capital the Private Banking Client has already invested in the products of companies belonging to the ČSOB financial group, while the principle of equal treatment of all unit holders is applied.

The Bank is entitled to reduce the individual fees set out in this Table of Fees if individually agreed conditions are met. The entry fee may also be reduced for persons in an employment relationship with the ČSOB Financial Group, in accordance with ČSOB's internal regulations on the granting of benefits to employees.

"HORIZON akciové" includes equity Funds with no subscription period and no maturity date.

"HORIZON zmiešané" includes mixed Funds with no subscription period and no maturity, excluding the HORIZON KBC Funds.

"HORIZON štruktúrované" includes structured Funds with a subscription period and a maturity date.

"HORIZON KBC" includes mixed Funds with no subscription period and no maturity, whose name begins with HORIZON KBC.

"OPTIMUM FUND štruktúrované" includes structured Funds with a subscription period and a maturity date.

"OPTIMUM FUND zmiešané" includes mixed Funds with no subscription period and no maturity date

Discounted entry fee when transferring capital between FUNDS:

In a transfer of capital between ČSOB AM Funds / KBC AM Funds, a discounted entry fee of 0.25% of the transferred amount + the difference of the entry fees will be charged if the conditions below are met⁴⁾.

Conditions for a discounted entry fee when transferring capital between ČSOB AM Funds / KBC AM Funds:

- proceeds from the redemption of Units in another ČSOB AM Fund/KBC AM Fund are used for the issuance of a Unit in the ČSOB AM Fund/KBC AM Fund (the value of the investment on the Subscription Order is equal to the value of the proceeds from the redemption of Units under the Redemption Order); and
- the time span between the delivery of the Redemption Order and the delivery of the Subscription Order to ČSOB does not exceed 5 business days, wherein the Subscription Order can be submitted only after settlement of the Redemption Order; and
- the name of the ČSOB AM Fund/KBC AM Fund in which the Client requests redemption of Units is the same as the name of the ČSOB AM Fund/KBC AM Fund in which the Client subsequently requests the issuance of Units; and
- the Client's written expression of intent to transfer capital between the ČSOB AM Funds / KBC AM Funds is attached.

A transfer of funds between ČSOB AM Funds / KBC AM Funds is not possible if the Client has submitted a Redemption Order or a Subscription Order for Units that are part of an internal transfer:

- in a hedged or structured KBC AM Fund or
- in a Fund that, within the meaning of this Table of Fees for Mutual Funds the exit fee is higher than 0%.

In the event of a transfer of capital between KBC AM Funds of the SIVEK Group, a 0% entry fee is charged.
